ABDİ İBRAHİM FOUNDATION WEBSITE COOKIE DISCLOSURE TEXT

Tracking technologies such as cookies, pixels, gifs ("**Cookies**") are small files placed on your devices such as tablets, phones or computers when you use online applications such as websites or mobile applications. Thanks to cookies, the servers of our websites and applications recognize your devices and remember, for example, your language preferences, saved usernames and passwords or your preferences on the site, or managing traffic on the site.

Pursuant to Law No. 6698 on the Protection of Personal Data ("Law"), your personal data regarding the cookies used on www.abdiibrahimvakfi.org ("Platform") may be processed by Abdi İbrahim Foundation ("Foundation") as the data controller within the scope described below.

Purposes and Legal Grounds for Processing Personal Data

Your personal data that are collected will be processed for the purposes set out below ("**Purposes**") within the personal data processing conditions and purposes specified in Article 5 of the Law. Cookies are used on the Platform for different purposes. Depending on the type of the relevant cookie used, the data processing purposes and the data processing condition under the Law that we rely on when using the relevant cookie may vary.

Mandatory Cookies

Mandatory cookies are placed on your device while you view the Platform and are necessary for the proper functioning of the online services offered or to fulfill an information society service you have requested (such as remembering log-in, form filling and privacy preferences, counting visitors on our website and measuring traffic). For the data processing activities we carry out during the use of these cookies, we rely on the data processing condition that "It is necessary to process personal data belonging to the parties to the contract, provided that it is directly related to the establishment or performance of a contract" within the scope of Article 5 of the Law.

Performance and Analytics Cookies

Performance and analytics cookies allow us to track and analyze the number of people viewing the Platform and Platform traffic. Thanks to these cookies, we can obtain information such as which areas on the Platform are visited most frequently or infrequently and optimize the traffic of the Platform.

For the data processing activities we carry out during the use of cookies, which are in question in cases where you explicitly request the relevant information society service, and first-party analytical cookies, which are statistical measurement tools used for purposes that do not significantly affect the privacy of users, such as obtaining general- statistical information, Art. 5 of the Law "Provided that it is directly related to the establishment or performance of a contract, it is necessary to process personal data belonging to the parties to the contract" and "Provided that it does not harm the fundamental rights and freedoms of the data subject, it is mandatory to process data for the legitimate interests of the data controller".

We rely on **your explicit consent**, if applicable, within the meaning of Article 5 of the Law for the data processing activities we carry out during the use of cookies and third-party analytical cookies, unless you have expressly requested the relevant information society service.

Functionality Cookies

Functionality cookies are cookies that are necessary to provide certain functionalities on the Platform and to remember your preferences for them.

For the data processing activities we carry out during the use of cookies in order to save the preferences you make in cases where you explicitly request the relevant information society service and thus customize the website for you, we rely on the data processing conditions "It is necessary to process personal data belonging to the parties to the contract, provided that it is directly related to the establishment or performance of a contract" and "Data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject" under Article 5 of the Law.

In cases where you have not expressly requested the relevant information society service, we rely on your explicit consent, if applicable, within the scope of Article 5 of the Law for the data processing activities we carry out during the use of cookies.

Below you can find the different types of cookies we use on the Platform. The Platform uses both first party cookies (placed by the Platform you visit) and third party cookies (placed by servers other than the Platform you visit).

To whom and for what purpose the processed personal data can be transferred

Your personal data collected in line with the fulfillment of the above-mentioned Purposes may be transferred to the companies and other technical service providers that we supply services for cookies within the scope of our legitimate interest, to legally authorized public institutions and legally authorized private organizations within the scope of the data processing conditions set out in Article 5 of the Law, in accordance with the rules regarding the transfer of personal data specified in Article 8 of the Law, within the scope of clearly stipulated in the laws and the fulfillment of our legal obligations.

Method of Personal Data Collection

Your personal data is collected electronically through cookies within the scope of the fulfillment of the above-mentioned Purposes.

Rights of the Relevant Person under Article 11 of the Law

We inform you that you have the following rights regarding your personal data in accordance with Article 11 of the Law:

- Learn whether their personal data is being processed,
- Request information if their personal data has been processed,
- To learn the purpose of processing personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom personal data are transferred domestically or abroad,
- To request correction of personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom personal data is transferred,
- Although it has been processed in accordance with the provisions of the Law and other
 relevant laws, to request the deletion or destruction of personal data in the event that
 the reasons requiring its processing disappear and to request notification of the
 transactions made within this scope and in case of incomplete or incorrect processing
 of personal data to third parties to whom personal data is transferred,
- To object to the emergence of a result to the detriment of the person himself/herself by analyzing the processed data exclusively through automated systems,
- To request compensation for damages in case you suffer damage due to unlawful processing of personal data.

You can submit your applications for your rights listed above to our Foundation by filling out the Data Subject Application Form, which you can access from the Personal Data Protection www.abdiibrahimvakfi.org. Depending on the nature of your request, your applications will be finalized free of charge as soon as possible and within thirty days at the latest; however, if the transaction requires an additional cost, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Board.



You can change your preferences regarding cookies at any time on the Website. In order to do this, turn the buttons on the cookie management panel "on" or "off" according to your preference and click the "Save settings" button. Afterwards, refresh the page to apply your settings.
